

PLYMPTON BOARD OF SELECTMEN  
MINUTES  
December 8, 2008

Attendees: Joe Freitas and Barry DeCristofano  
Absent: John Henry

Meeting called to order at 7:00 pm.

The Board met Mr. Dempsey from the Conservation Commission. Mr. Dempsey requested permission to contact Town Counsel regarding the eligibility of committee members that weren't present at an initial meeting on a Notice of Intent filing to vote on the eventual determination of the issue. Since the Commission sent the filer (Mr. Quackenbush) back to, essentially, start from scratch with the filing, it was felt that the members should be eligible. The request was approved. The Assistant Assessor, Mr. Dunn, met with the Board to discuss the sharing of costs for the town's car (the "Green Car") between his office and the Tax Collector's. Mr. Dunn and the Tax Collector will meet and work out the details.

On the recommendation of Chris Lawrence, Brian Wick was appointed as the Alternate-to-the-Alternate to represent the Town at meetings of the Plymouth/Carver Aquifer Action Committee when, due to previous commitments, neither the Primary (Mr. O'Leary) nor the Alternate (Mr. Lawrence) can attend. Mr. Wick is usually in attendance in his role as a representative of the Cape Cod Cranberry Growers Association. Motion – Mr. DeCristofano, 2<sup>nd</sup> – Mr. Freitas. 2-0-0

Paperwork due to the State Alcoholic Beverage Control Commission providing an estimated Town population for the coming year was approved and signed for submittal. Motion – Mr. Freitas, 2<sup>nd</sup> – Mr. DeCristofano. 2-0-0

A "Meet the Artist" gathering will be held at the Frame Shop on Rt. 106 on Sunday, December 14<sup>th</sup>, at 1 p.m. Plympton artists will be there.

Santa comes to Plympton on December 12<sup>th</sup> at 6 p.m., at the gazebo on the Town Green. Pictures with Santa will be taken afterwards at the First Congregational Church (co-sponsored by the Old Home Day '09 Committee). Permission to use the Town Green for this was granted by the Board. Motion – Mr. DeCristofano, 2<sup>nd</sup> – Mr. Freitas. 2-0-0
