March 23, 2009

Attendees: Joseph Freitas, Barry DeCristofano, and John Henry
Meeting called to order at 6:15 PM

Town Treasurer, Carolyn Northon and Town Tax Attorney, Laura Brown reviewed the Piscionere tax title foreclosure property. Ms. Brown recommended that Town hire an Environmental Attorney to review file. The Gilbert case was filed last year and is being reviewed in land court. Procedures for collection of real estate tax foreclosures were discussed.

Mr. Alan Vautrinot submitted a Draft – Warrant Article for Zoning ByLaw change.

Resignation of Chrissy Gurney from the Dennett School committee was read.

7:00 PM APPOINTMENT: Mr. Young Kang continuation of expansion hearing. Mr. Kang and his Attorney, Warren Kirshenbaum reviewed the newest expansion plan with the Selectmen. The Planning Board recently met with Mr. Kang and listed two conditions:

- 2 lites near top of building need mounting
- Landscaping will be completed by June 30, 2010

There was a long discussion as to parking spaces on property. Mr. Henry recommended that Mr. Kang go to the Zoning Board of Appeals to reduce the number of parking spaces in order to move forward with expansion plans or go to the Department of Environmental Affairs with plans.
