Meeting called to order at 6:30 PM

6:50 PM APPOINTMENT: Tax Collector, Carolyn Northon presented a Warrant Article MGL Chapter 60, Section 15 effective July 01, 2009 to charge for each written demand issued by the Tax Collector fee of \$25.00 be added and collected as part of the tax.

VOTED: Motion made by Mr. Henry to accept the Article as presented by the Tax Collector. Second Mr. DeCristofano. 3-0-0.

Plympton Board of Health recommendation that Plympton and Halifax organize distribution of medical supplies in the event of a natural disaster. Mr. Henry will review and report back to Board of Health and Selectmen.

VOTED: Motion made by Mr. DeCristofano to grant Mr. Kang's request to expand his liquor store as described in his application dated January 15, 2009 subject to:

- Approval by the DEP of a plan, meeting all Town Bylaws unless waivers have been granted by the ZBA, that they find acceptable for the protection of the public water supply located on Mr. Kang's property.
- The issuance of a final occupancy permit for Mr. Kang's building by the Town's Building Commissioner.

Second Mr. Henry 3-0-0. Copy vote to: Mr. Kang, Building Commissioner, Board of Health, Planning Board and Board of Appeals.

VOTED: Motion made by Mr. DeCristofano to recess at 7:10 PM to attend Wage and Personnel meeting with Finance Committee members. Second Mr. Henry 3-0-0.

The Finance Committee recommended a level funding budget for Town House employees. Wage and Personnel members agreed with the recommendation.
