Discussion was on the Quackenbush order of conditions and the new Wet Lands By-law. The Selectmen noted that the signed Order of Conditions had a few omissions. Mr. Dempsey agreed. He added to the discussion stated that the Town By-law gives the Commission the authority to not consider the 25' "no touch" zone and the vernal pool considerations as part of their vote.

Ms. Royal was present and stated that the Town could benefit from hiring a part-time Conservation Commission Agent to work with the Commission.

The Selectmen discussed the fiscal year end appointment schedule.
