July 20, 2009

Attendees: Barry DeCristofano and Joseph Freitas

Meeting called to order at 7:00 PM

Andrew Snow completed his Eagle Scout Project. Andrew designed and constructed a new Plympton Public Library Monument that is on the front lawn of the Town Library. Andrew thanked his parents, Sunrise Gardens, Mrs. Sam Moniz, Doug Ferguson and Lawrence Ready mix for assisting him with the project. Andrew raised \$2,300.00 for the "Buy a Block" Campaign. 100% of every dollar donated was used for supplies for the monument. The dedication ceremony will take place Saturday, August 01, 2009 at 10:00 AM at the Library. All are encouraged and welcome to attend the ceremony.

7:00 PM APPOINTMENT: Mr. Young Kang – Liquor License violation hearing. Mr. Kang and his Attorney, Warren Kirshenbaum attended the meeting. Mr. Kang stated that there was a miscommunication of earlier facts. Attorney Kirshenbaum spoke the rest of the time during the hearing. He said he was very angry over the fact that he tried to cooperate with the Board and stated that he will consider revisiting the Alcoholic Beverage Control Commission.

VOTED: Motion made by Mr. Freitas to suspend Mr. Kang's liquor license for three days (a consecutive Friday, Saturday and Sunday) with only one day of the suspension required to be observed, either Friday, August 7th or Friday August 14, 2009. (the choice of Mr. Kang).

VOTED: Motion made by Mr. Freitas to approve the positions of Wiring Inspector and Zoning Enforcement Officer be designated as Special Municipal Employee positions for a period of a one year term (until June 30th, 2010) in accordance with M.G.L. c 268 A. for Robert Karling.

Selectmen signed the copier service contract for model #E 233 and 207.

VOTED: Motion made by Mr. Freitas to sign Town Accountant's year end changes.

VOTED: Motion made by Mr. Freitas to approve the transfer from the Town's Stabilization Account \$190,000 to the Town's Money Market Account. The money will be returned to the Stabilization Account in full, with interest with funds from the 2010 tax income. Second Mr. DeCristofano. 2-0-0.

VOTED: Motion made by Mr. Freitas to appoint Robert Inglis to Forest Fire Warden and Civil Defense Commission until June 30, 2010. Second Mr. DeCristofano. 2-0-0.

VOTED: Motion made by Mr. Freitas to Edward McCune III to the Plympton Historic District Commission until June 30, 2012. Second Mr. DeCristofano. 2-0-0.

VOTED: Motion made by Mr. Freitas to approve purchase of 7 radio pagers and consult Town Accountant for availability of funds. Second Mr. DeCristofano. 2-0-0.

Mr. DeCristofano reported that computer line for the Fire Department will be reviewed for maintenance repair costs, etc.

VOTED: Motion made by Mr. Freitas to allow CERT members the use of the Selectmen's Meeting Room the second week in Wednesday every other month, beginning September 09, 09 at 7:00 PM. Second Mr. DeCristofano. 2-0-0.

Mr. Freitas reported that he wants to set up a meeting with the Towns of Halifax and Kingston Board of Selectmen and Finance Committees regarding the budget sometime this autumn.
